

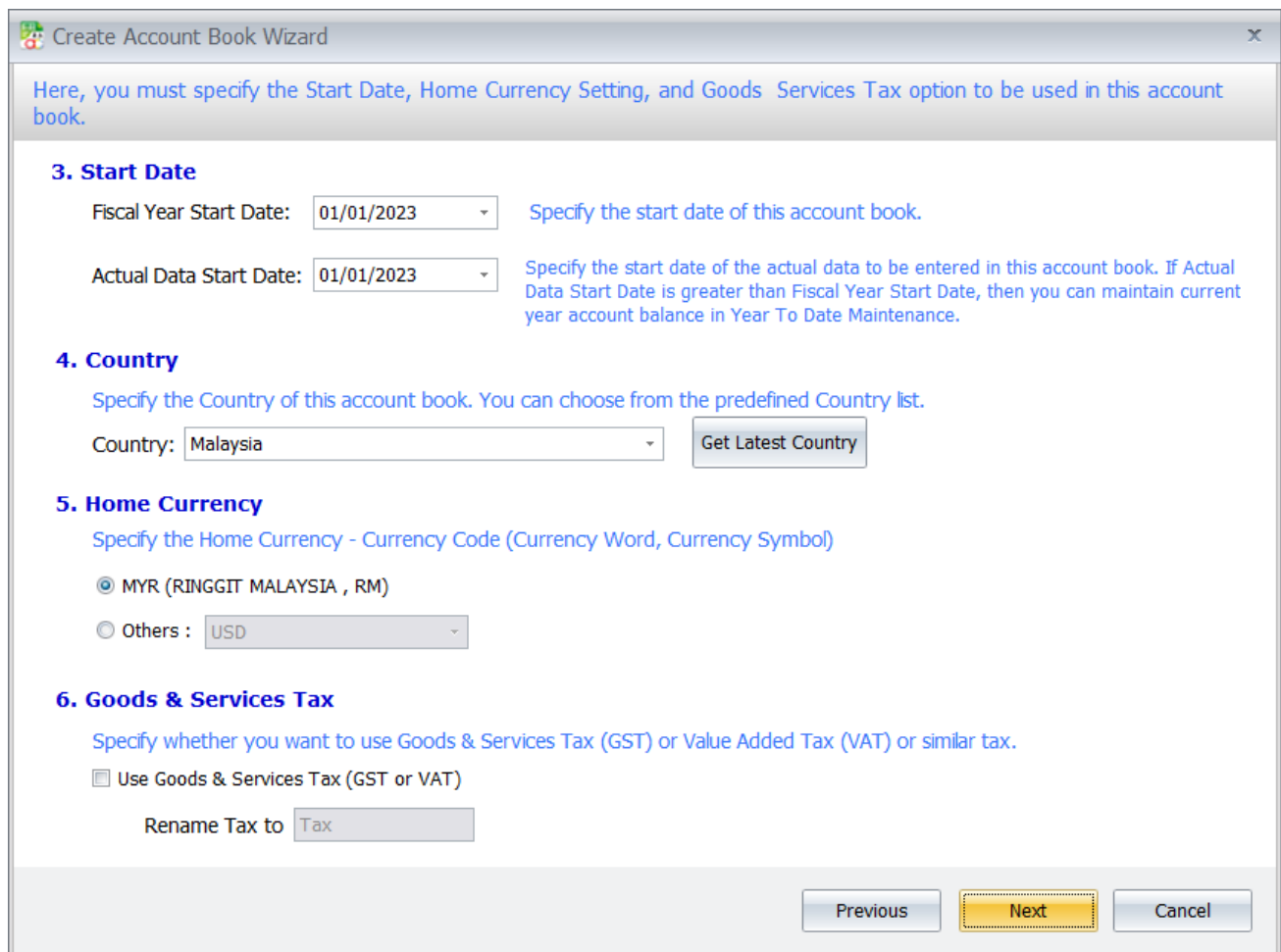
What's New in Version 2.1.7.22

Upgrade DevExpress to 22.2.6

In this version, AutoCount Accounting had upgraded its **DevExpress to version 22.2.6**. This also means that user had any plugin, it will need to **be reinstalled with the compatible version**. Any other 3rd party plugins installed in AutoCount Accounting are also required to be **recompile** for compatibility purpose.

Revamped License Control from Currency to Country

From this version onwards, AutoCount Accounting will now **recognize license based on country setting**. User can find that when create new account book, it will be **country based instead of currency based**. The home currency usually will follow the currency code of the country selected. User however has the option to choose another set of currency (USD, CNY and EUR) but this will require Advanced Multi-Currency module (Refer Figure 1).

Here, you must specify the Start Date, Home Currency Setting, and Goods Services Tax option to be used in this account book.

3. Start Date

Fiscal Year Start Date: Specify the start date of this account book.

Actual Data Start Date: Specify the start date of the actual data to be entered in this account book. If Actual Data Start Date is greater than Fiscal Year Start Date, then you can maintain current year account balance in Year To Date Maintenance.

4. Country

Specify the Country of this account book. You can choose from the predefined Country list.

Notification UI

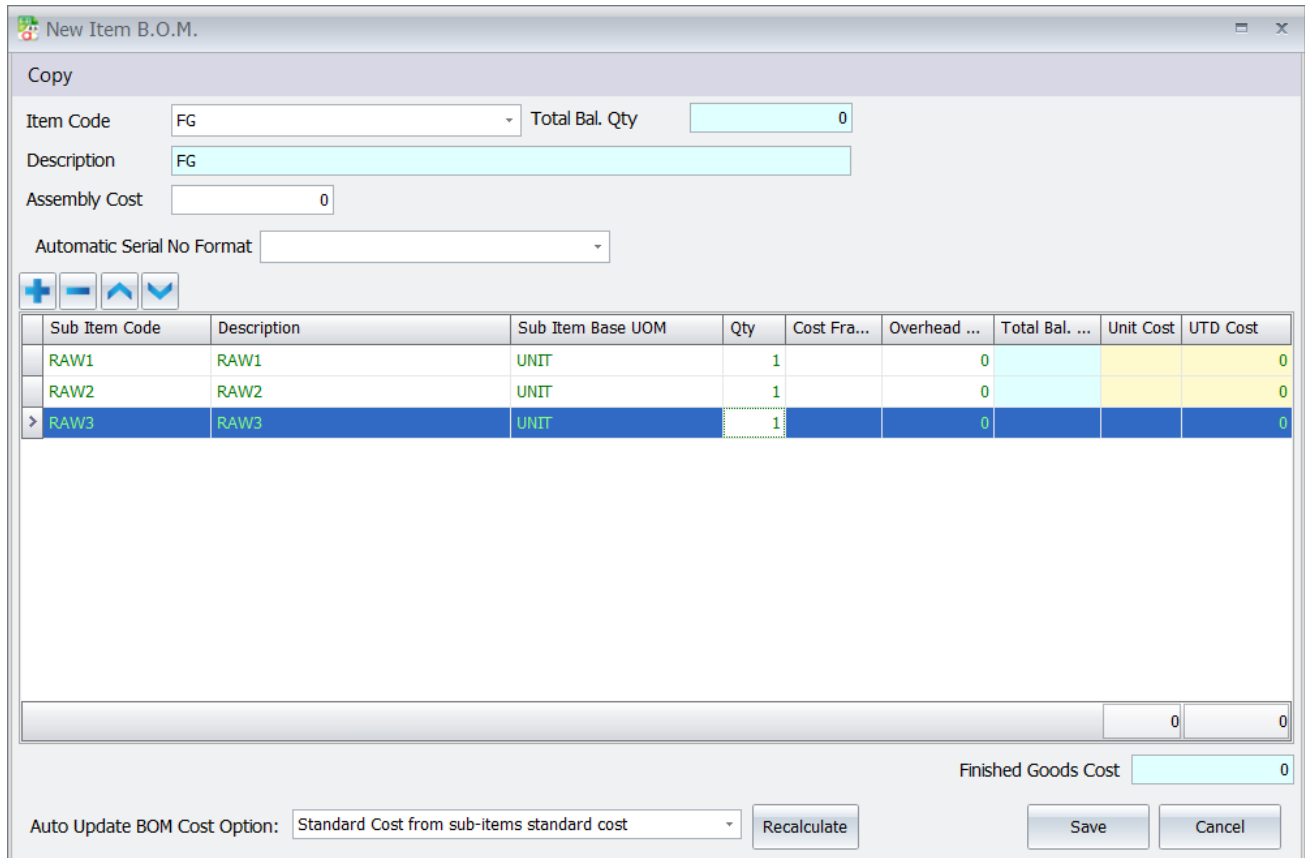
AutoCount Accounting notification dialog box UI is now changed to a more modern style design (Refer Figure 2).

Item BOM Maintenance show UOM of Sub item

User can now know immediately the UOM of sub item from Item BOM Maintenance as well as when create new Item BOM. A **new column** had been added to **capture the UOM of the sub item** (Refer Figure 3 & 4). This will provide some convenience for user that need it especially if they wish to export the data out from Item BOM Maintenance. Item BOM Maintenance can be found under **Menu → Stock → More Stock Maintenance → Item BOM Maintenance**.

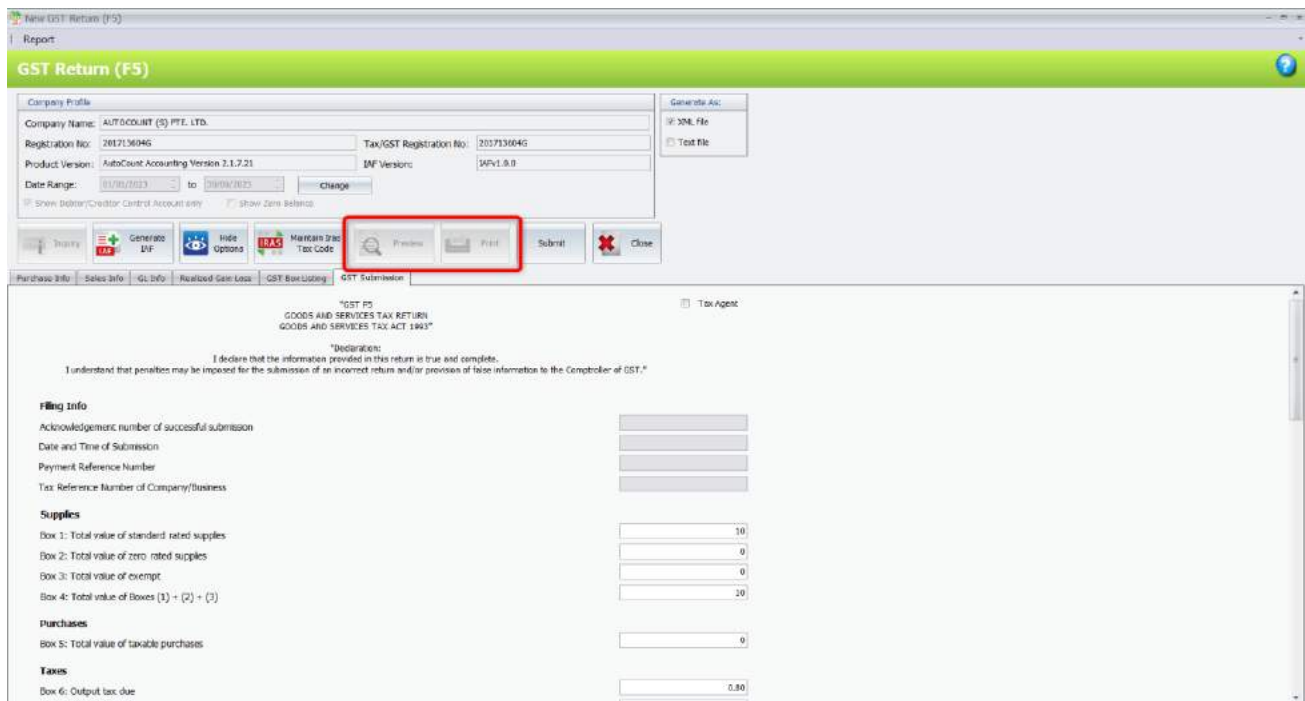

IRAS GST Submission to Print GST Submission Result (Singapore)

User can now print their IRAS GST Submission as a new **Preview and Print** function has been added (Refer Figure 5). User can now print out a physical copy or make a PDF copy for own storage. However, this Preview and Print is **only available after submission**. This function is under **Menu → Tax → IRAS → IRAS GST Submission**.

Option to hide inactive Project or Department for financial report with Project or Department Format

A new option “**Hide Inactive Project or Department for comparison Financial Report**” had been added to provide some convenience for users that runs a lot of projects or departments (Refer Figure 6). This option can be found under **Menu → Tools → Options → General → Application Settings**.

Sometimes these projects or departments might be inactive (Refer Figure 7) after a period and it will be difficult for user to use our Project or Department format (EG: Project comparison – YTD) in our financial report as there will be too many Project or Department selection appear out for selection. Therefore, this option will come in handy to filter out those inactive projects or departments so that user can do the selection easily by removing those unwanted inactive codes (Refer Figure 8).

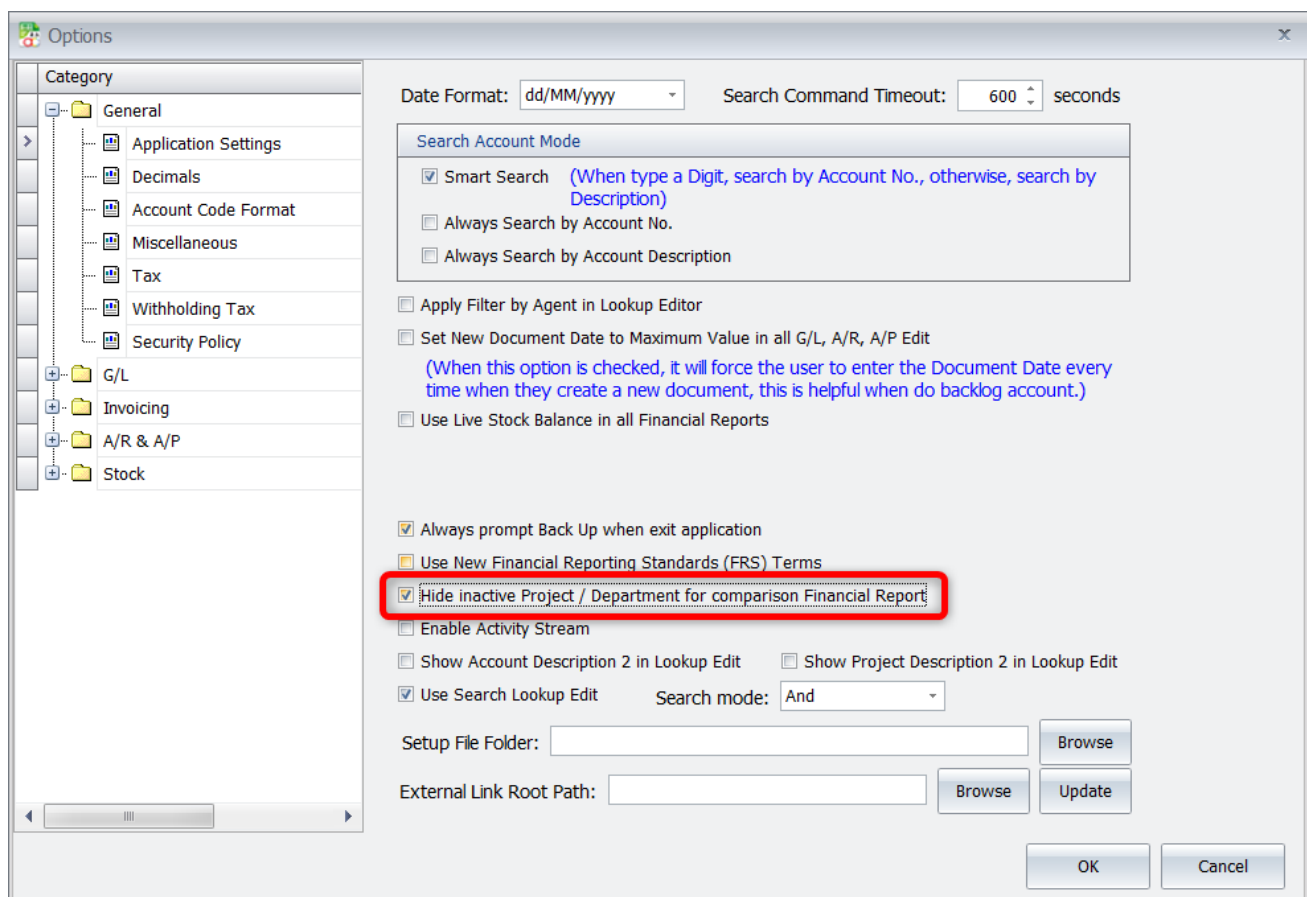

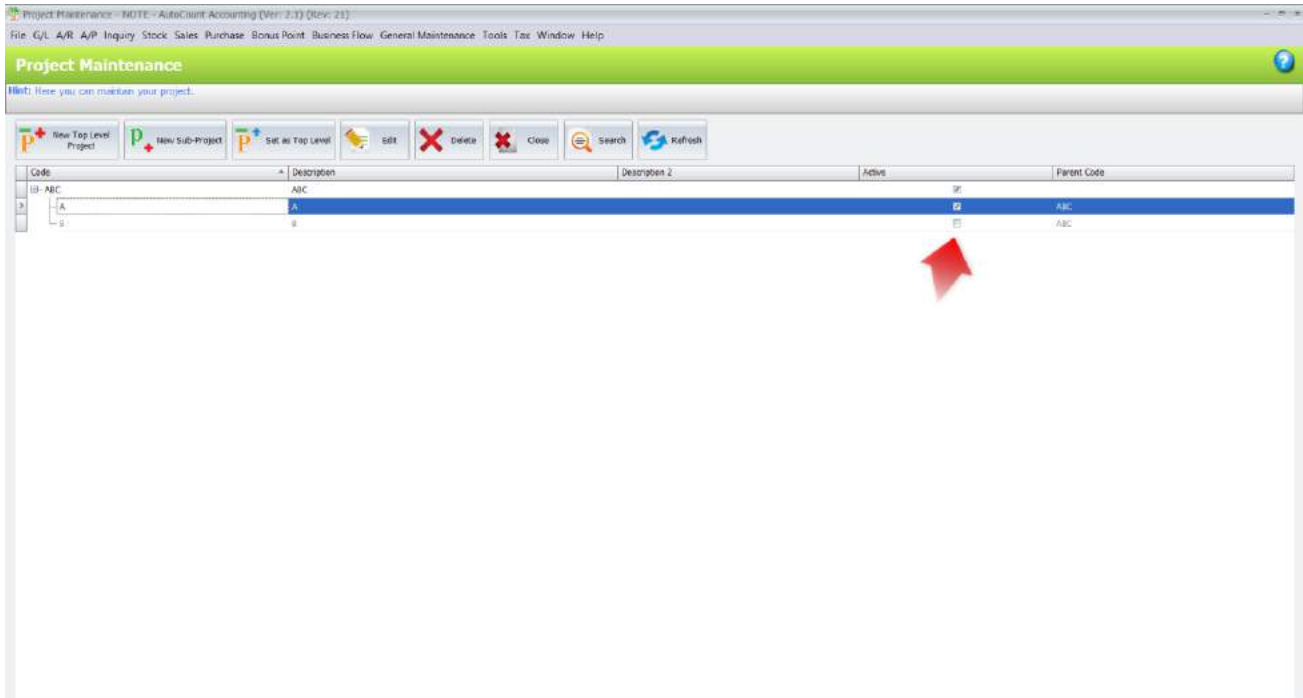

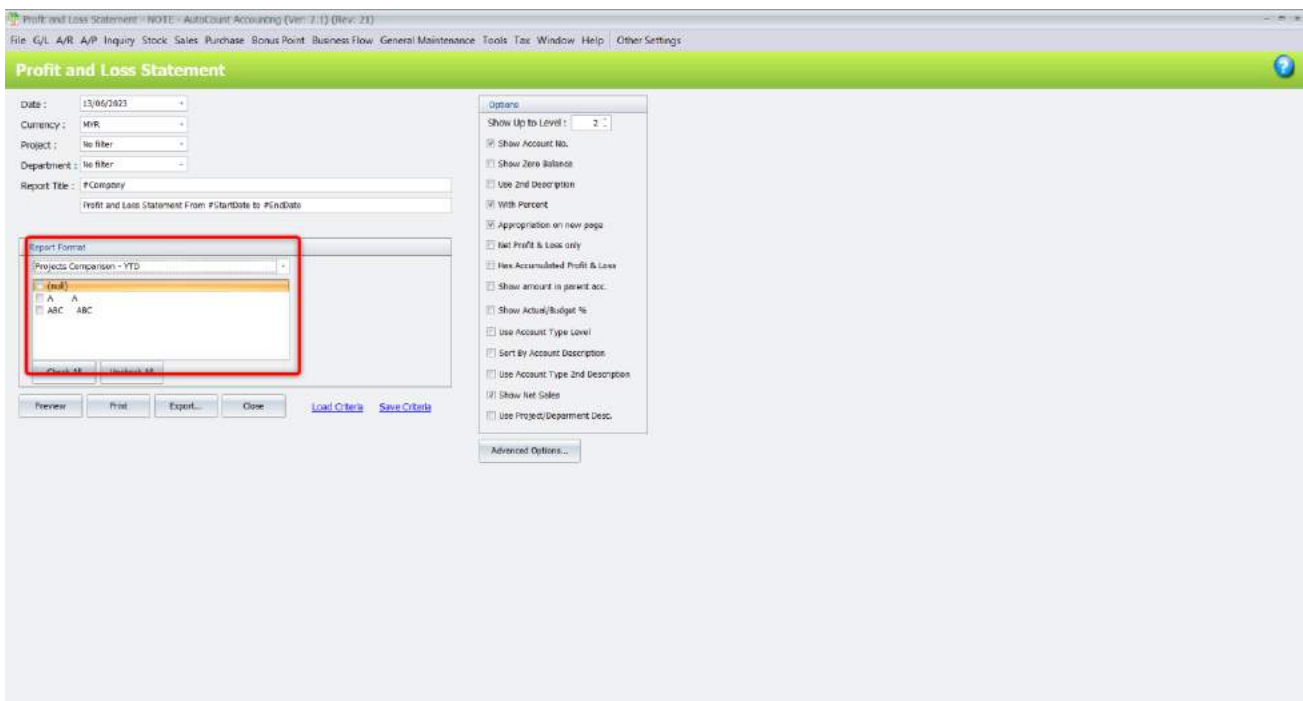

Access Right for “Set Column Caption”

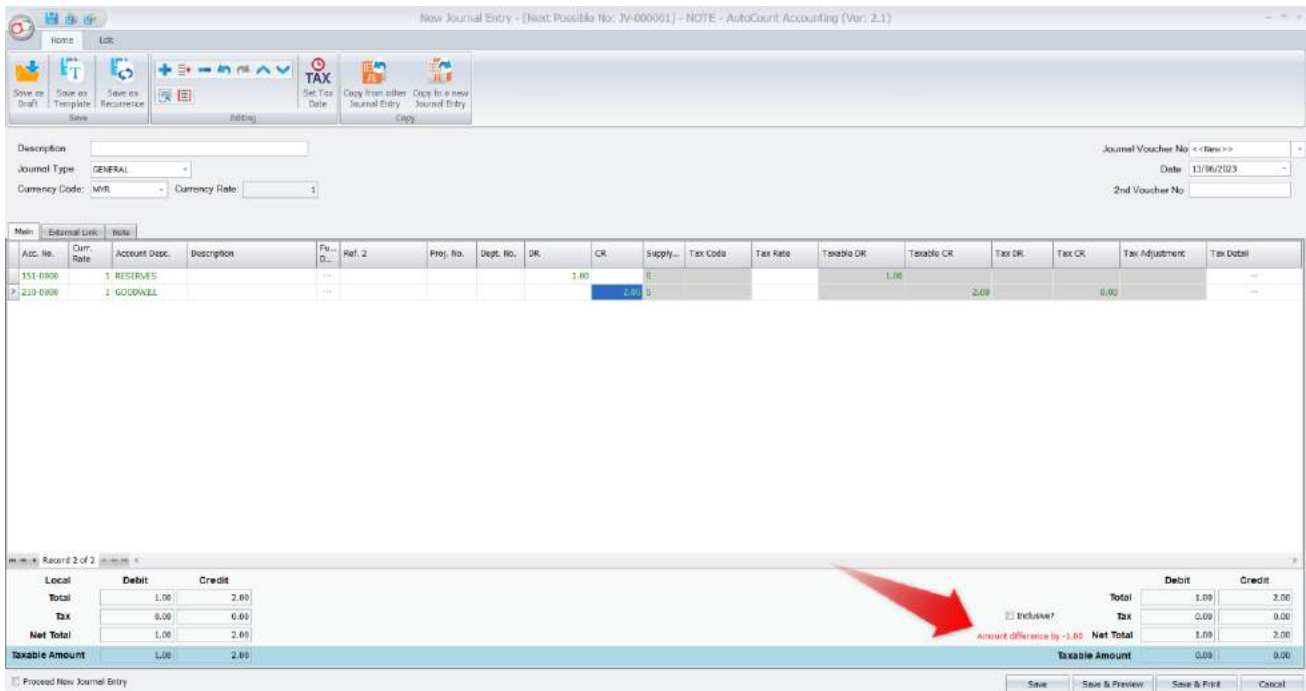
A new access right had been added to provide additional control on who should access the “Set Column Caption” function. User can access this from **Menu → General Maintenance → Access Right Maintenance → AutoCount Accounting → System → Behaviors → Allow Set Column Caption** (Refer Figure 9).

Journal Entry to show differences if DR and CR not balance

System will now show a line of red wording with the difference amount if the DR and CR of the Journal is **not balance** (Refer Figure 10). This is to let the user know immediately how much the journal is not balance. Journal Entry can be found under **Menu → G/L → Journal Entry**.

Access Right for “Edit Master Data”

A new access right had been added for the rest of Purchase and Stock documents on who should access the “**Edit Master Data**” function. Previously this access right is only available for Sales document and now it had been implemented into Purchase and Stock to consistently control this function accessibility. User can access this from **Menu → General Maintenance → Access Right Maintenance → AutoCount Accounting → Invoicing → Under Purchase or Stock → Under a specific Document → Edit Master Data** (Refer Figure 11).

Layout features in Item Price Book Entry

Layout features such as save layout, load layout, reset layout and layout manager had been implemented into Item Price Book Entry (Refer Figure 12). Users can now **customize their preferred layout** and save it as default for easy viewing in the future. Item Price Book can be found under **Menu → Stock → More Stock Maintenance → Item Price Book Maintenance**.

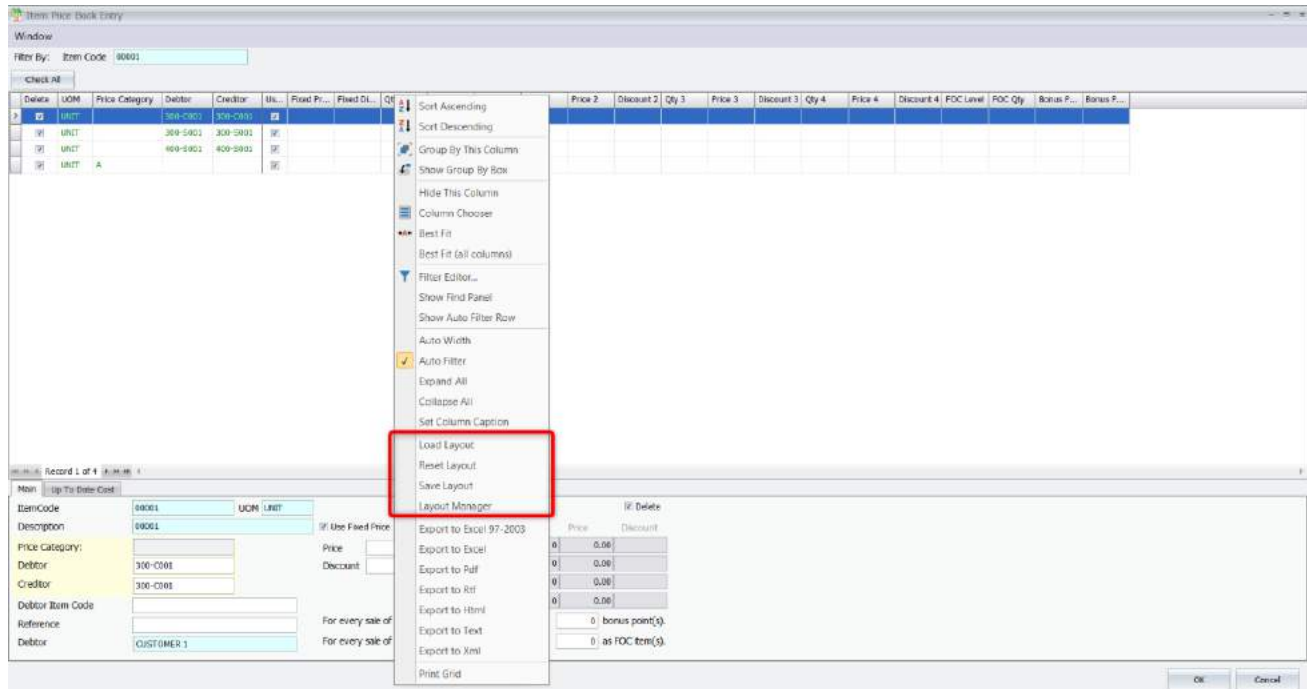

Tax Date for all Countries

Tax Date function is now **available for all countries**. For countries that does not have configure setup function like Malaysia GST / SST, user will need to **set the Deferred Input Tax and Output Tax Account at Tax Setting under Tax Code Maintenance** first (Refer Figure 13).

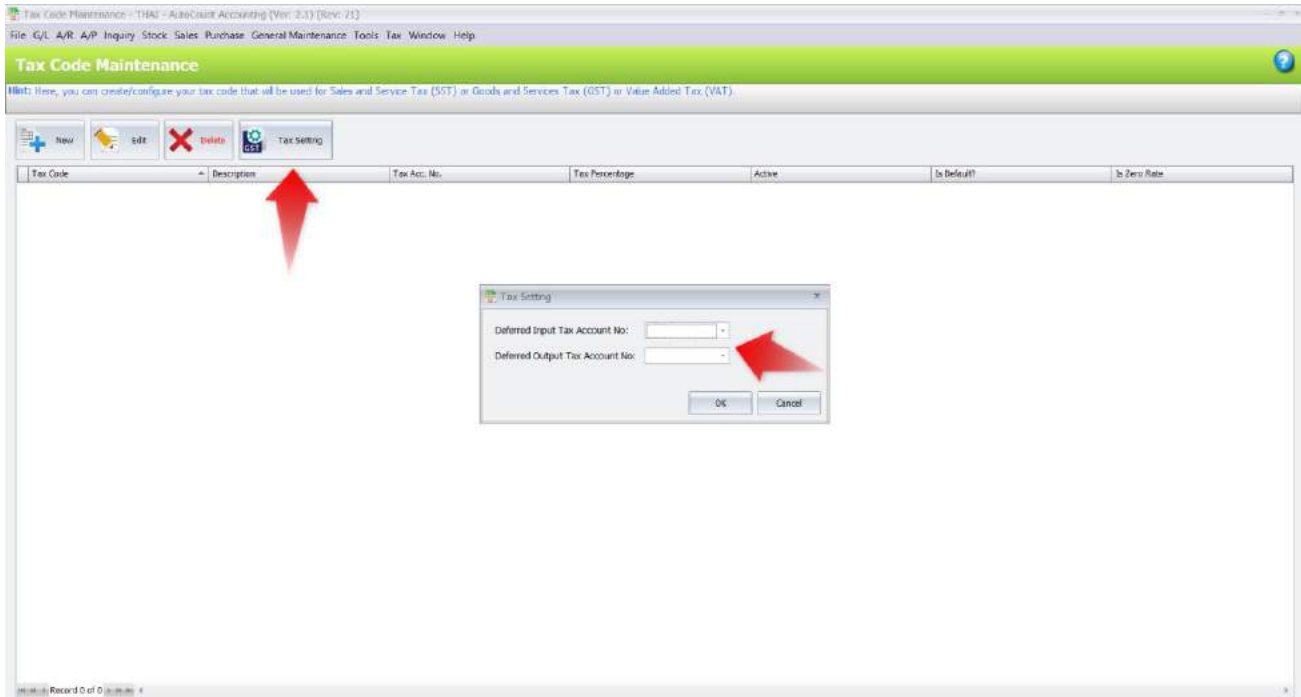

Auto Charset for Print Bar Code Reports

In DevExpress 22.2.6, it has come with a new feature for Report Design Barcode control which allow the **charset property to be set “Auto Charset”** (Refer Figure 14). This had been defaulted in all print barcode system report so that user will not face any incompatibility when converting their ItemCode or Barcode field to scannable barcode. User can find this function under **Menu → Tools → Print Bar Code**.

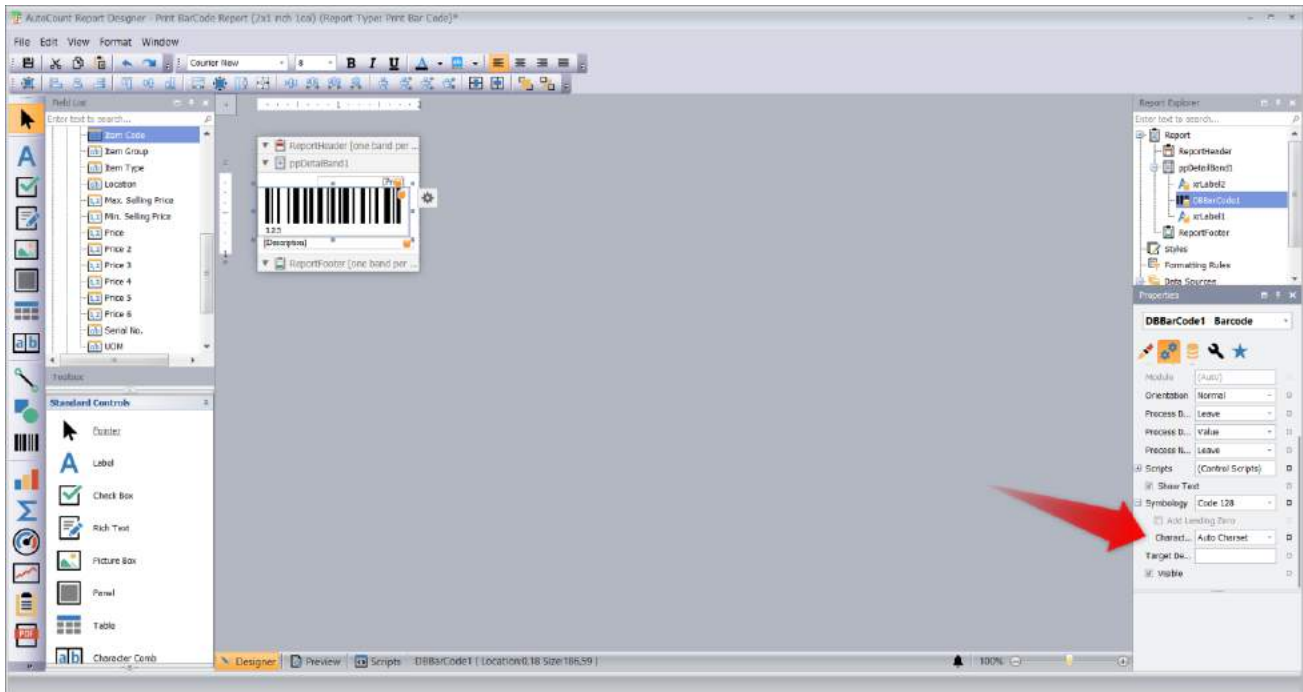
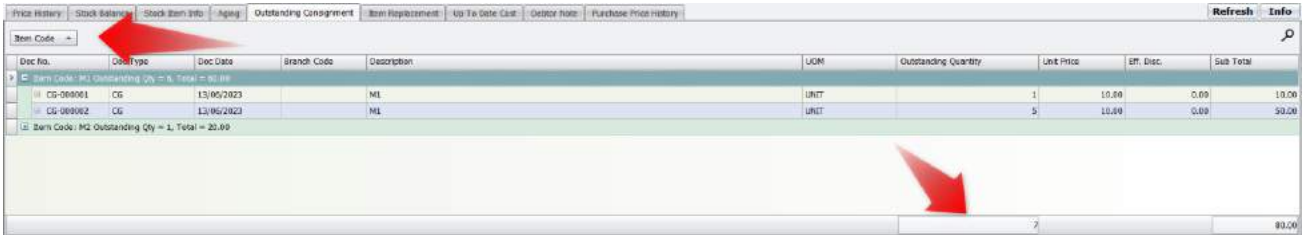

Group Panel and Summary Footer for Outstanding Consignment tab in Show Instant Info

Tracking outstanding consignment information is important for users that practice consignment business. Thus, in this version, AutoCount Accounting had implemented **group panel and summary footer** feature into the grid when user view their **outstanding consignment through Show Instant Info**. User can now drag any available column in the grid for grouping purpose and a sum of Qty column is automated at the footer as well (Figure 15).

Branch Code for Consignment Group Select

Another field “**Branch Code**” had been added into **Consignment group select** for better splitting of consignment document to transfer into Invoice or Consignment Return. This selection can be found during partial transfer from consignment, tick on the use Group Transfer and there will be a “**Group Select**” button (Refer Figure 16). Click on the button to adjust the setting accordingly.

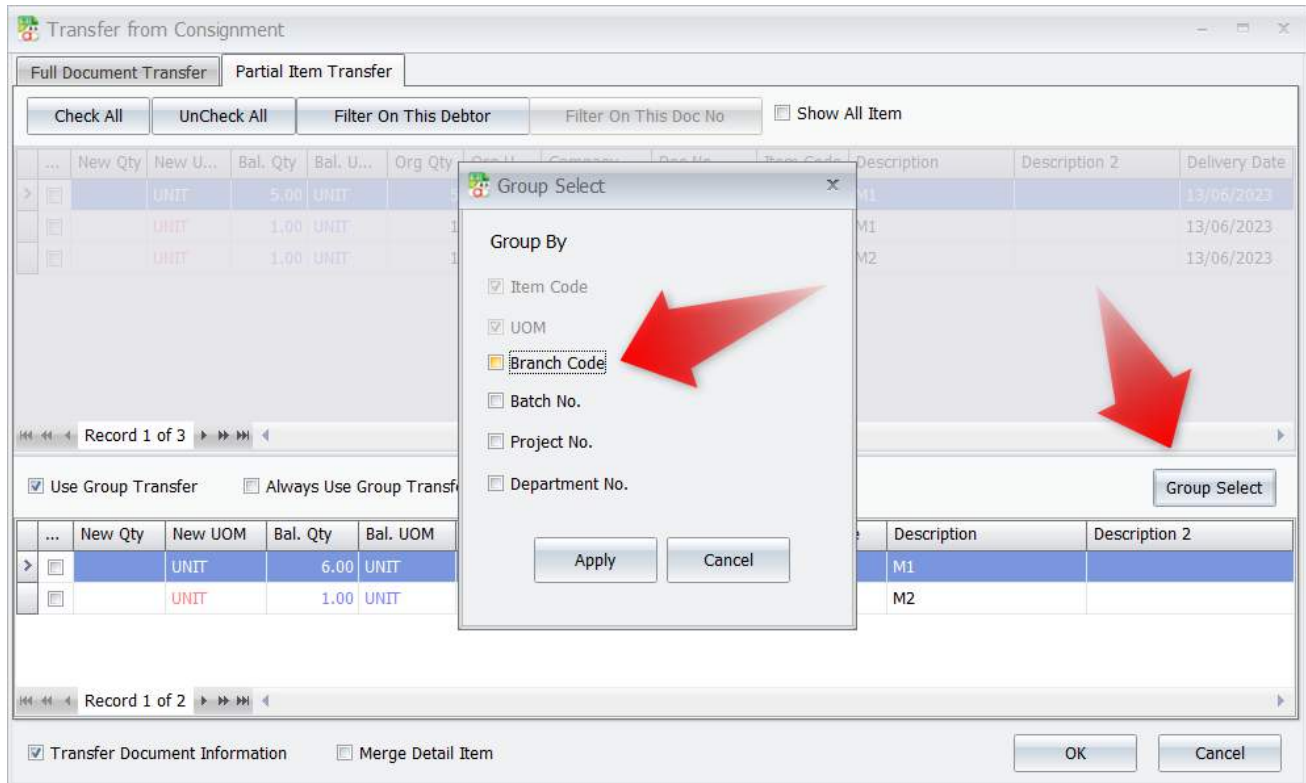

Fix Stock Assembly Auto Generate Serial No List Problem

A new fix had been added into AutoCount Management Studio. This fix is to fix an old bug where if user use our Auto Generate Serial Number function for new assembled Finished Goods with serial number. There are some tables where the serial number list data is store incorrectly. Running this fix will check and correct this data. This function can be found under **AutoCount Management Studio → Menu → Data Consistency → Fix Assembly Auto Generate Serial No List Problem** (Refer Figure 17).

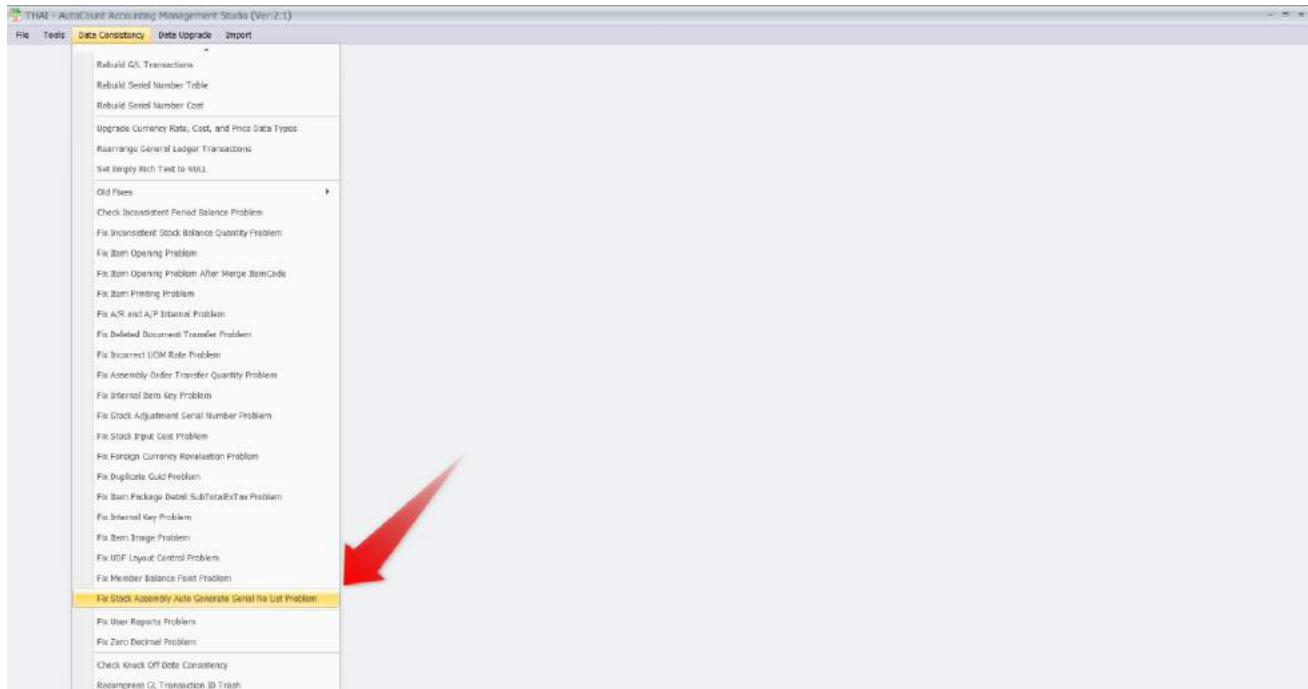

Others

Some other key highlights of this version which does not require further explanation:

1. **Print Barcode import from transaction to follow item sequence** – Under Print Barcode, if user import transactions it will now follow the sequence in the transaction to print which item first, second and so on. It will now not auto sort by Item Code and cause the printing arrangement to be different from the transaction.
2. **Remember Item Package “Add as Item Template” option** – In adding Item Package screen, there is a checkbox selection of “Add as Item Template” which will now always remember your previous selection. This will provide convenience for users that always want to check this selection and can avoid forgetting to check this when performing data entry.
3. **Bank Book Analysis Widget to have Automatic Set Date** – A new option added for Bank Book Analysis “Automatic Set Date” so that user can enable this so that the system will always show up to date results for this widget.
4. **Import AP Invoice from Excel to import Original DocDate** – Previously user unable to import Original DocDate of AP Invoice from Excel as the system does not support such column. However, this had been enhanced and user can now do so by adding DocDate2 into the Excel header to import this column.
5. **Network User Monitor rename “User Name” to “Window User Name”** – Renaming of this column so that user will not confuse which “User Name” actually that column refers to.
6. **Audit Trail to records details if direct delete from ARAP** – System will now record the details if user perform delete directly from ARAP on sales or purchase transactions. This is to provide additional information so that tracing of info can be done easily.
7. **Stock Detail Listing to show sum of Quantity at Footer** – By default all stock detail listing report will auto sum the quantity and show at the grid footer.
8. **Singapore country to select Supply / Purchase field in CN & DN** – The field “Supply / Purchase” field in Sales and Purchase CN and DN is now open for Singapore. Account book that runs under Singapore can now access this field and change it value according to their needs to select the suitable tax code.
9. **BatchNo column in Outstanding Detail Listing Report** – Previously AutoCount Accounting did not show BatchNo column in Outstanding reports. From this version onwards, this column had been added so that user able to have a better view of their outstanding batches that is yet to process.
